On September 25, 2024 I received a call from Sara, at the Harris County Clerk's office, who insisted that the "claim docket" was an internal spreadsheet for the courts use only. She also made it clear that there had been no claims filed. I stated that was hearsay and that I needed something in writing to verify that fact. Her reply was that it was an internal document for the courts use only. That's nonsense. The copies I am requesting are public records.

Please take note of the attached statute.

Tex. Est. Code § 52.002(a) The county clerk shall maintain a record book titled "Claim Docket"

Tex. Est. Code § 52.002(b) The county clerk **shall assign one or more pages of the record book to each estate**.

I made a request for certified copies of the claim docket pages for Estate of Elmer Brunsting No. 412,248 and Nelva Brunsting No. 412,249. I am well aware that no claims were ever filed against either estate but I need certified copies of the blank claim docket pages assigned to each of those estates. My request was in writing and I require a response in writing.
