My numer is 925-349-8348 if you have any questions. As you have been made aware, there are no claims in the estate of Nelva Brunsting No. 412249-401 and there never was any question of jurisdiction over the Elmer H. Brunsting share of the family living trust as the statute of limitations expired eight days before the -401 non-probate tort suit was unlawfully filed in that court.

Please pay special attention to the docket tampering portion of my affidavit and ask your IT people to look at the syslog to see whose credentials were used for these two events.

Thank you for your email and for your patience as we work to clarify your request. I apologize for any confusion you experienced in the process.

To address your inquiry, the "Claim Docket" you are referring to is indeed a public record that the County Clerk maintains in accordance with the Texas Estates Code § 52.002(a) and (b). As per the statute, the County Clerk is required to maintain a "Claim Docket" and assign pages to each estate, even if no claims have been filed.

However, in the cases of Estate of Elmer Brunsting (No. 412,248) and Nelva Brunsting (No. 412,249), no claims were filed, which means that no claims would appear on the pages assigned to those estates. While the office staff may have referred to internal processes in error, your request for

certified copies of the blank claim docket pages is valid. We will proceed with generating certified copies of the claim docket pages for the estates you mentioned, showing that no claims were filed.

You will receive a written response confirming this and the certified copies of the blank claim docket pages shortly.
