Hello,

It's been really crazy around here for the last 3 weeks. First I wrecked my Prius trying to avoid hitting a kitty in the road. I just got it back after 15 days in the shop. We don't have rental coverage on our insurance, so I had to foot the bill or not have transportation during that time. I can always ride the bus to and from work, but it's difficult to get to the gym and then to work via bus and my morning swim is much more important than money. I had my annual physical last week and my doctor is so proud of me! All of my systems are in great shape and I've really got a handle on the diabetes. I can probably stop the medication in a few more months. Yeah!!!!

The reason I haven't written is because our computer crashed and we lost all of our data. I'm glad you wrote me so I can start collecting email addresses again. If you would, please send me my siblings' current email addresses. It is rather depressing to be an IT wizard and not have a backup of my own computer, so I've ensured that it will not happen again.

Dave got his liver and has been home from the hospital about a week or so. Kevan and I went over there Friday afternoon and ironed out the details of the deal. Dave is not allowed to stay outside for any length of time, or see his grandchildren for 6 months due to bacteria they may be carrying. I'm not sure why we were allowed to be there but I guess adults don't have the same bacteria???????? He will NEVER be allowed back in the lab. Being around all of the acrylic and other lab related substances puts a big strain on the liver if it's not in good order. Anyway, Kevan will take over officially on May 1, although he has been running it for the last several months. 


Moss family gathers to celebrate Century Farm

HULL, Iowa (STPNS) -- Over 50 Moss relatives gathered at the family farm, one mile west of Hull, to celebrate after the farmstead was recognized as a Century Farm at the Iowa State Fair in August.

"Some family members were in Des Moines for the ceremony at the Fair, but we thought it would be great to have a big family reunion at the farm over Labor Day Weekend," said Arlan Moss, who lives on the Century Farm.

Iowa Secretary of Agriculture Bill Northey recognized Century Farm families at the Fair. To qualify, a family must have owned their farmstead for 100 years or more. The Iowa Dept. of Agriculture and Land Stewardship has partnered with the Iowa Farm Bureau Federation since 1976 to recognize families that have owned and worked a farm for 100 years or more.

This year 344 farms were recognized, making more than 16,200 farms from across the state that have received this recognition.

The award meant a lot to Arlan and his wife, Ruth, and was especially meaningful to his mother, Harriet.

In 1908 Cornelius and Tryntje Moss purchased their first farm, 240 acres, from the Brunsting family. Previously, the couple had rented a farm one mile south of the Moss farm.

Later, their son Jacob and his wife, Lena, took over the farm and their son, Art, along with his wife, Harriet, followed.

In 1976, Art and Harriet moved to town after Arlan and Ruth were married.

The farm has expanded as more land and buildings were added. Technology has changed farming methods.

All the Moss families milked cows until 2000, when the cows were sold.

Today Arlan and Ruth, along with their son, Craig, grow corn and soybeans, finish hogs and raise cattle, including Holstein bull calves and beef cattle. Years ago they raised hogs, farrow-to-finish, and now are part owners of a farrow-to-finish business, Long View Farms, in Wagner, SD.

During the Labor Day Moss family reunion all the children, grandchildren and great-grandchildren of Art and Harriet returned to the farm.

"It was a very special time and a good reason to have all the family get together," said Arlan with a smile. "They'd all spent time on the farm and had fond memories. That might have included getting in trouble or something as like riding the 4-wheeler."

Arlan, Ruth and their daughter JoElyn put together a farm scavenger hunt, which they described as a 'memory walk through the farm'. The scavenger hunt included questions like 'where did we go to gather eggs' and 'where was the old outhouse'?

"Some of the grandkids didn't know what we were talking about," said Arlan. "But it gave all us of the opportunity to tell some good stories."

I have added the bills I have so far. They total \$17,833.00. There is one that I have already gotten a second past due notice for. It is for Carl's Life Flight helicopter transport. The bill was \$10,000. The insurance only paid \$1,500. That leaves us responsible for \$8,500.00. It is considered to be out of network so insurance did not pay much at all.

I have not gotten a past due yet on any of the others. So many of the doctors from UT who saw Carl at Hermann (and there was a different batch of them weekly because it is a teaching hospital) were out of

network and the insurance did not pay because our deductible for out of network doctors is very high.

When you get your funds at the end of the month it would be easiest if you just mailed a check to me so I can deposit it and then I will pay whatever bills I can.
