He wants to hear if she's doing better Friday - only said though that he might start her on Prednezone then for her weezing, and I believe another antibiotic if she is still running a fever.

HI,

I heard about the drama on Sat. morning. Thanks for taking care of her. Sounds like she wasn't taking bp meds either when the dr. prescribed them over a year ago. She said that her bp was fine in the dr.'s office a week or so ago (about 122). But sounds like something she should keep up w/, especially since they noted that "silent" heart attack on her ekg a few years ago when she had the 2nd knee surgery. She was supposed to have the endoscopy on Tues for her upset stomach that she's been having off and on, but she says that's better (she thought it was the stress of dealing w/ all the paperwork after daddy's death). She was also supposed to have a cat scan for the same reason, but she's probably going to blow that off too. She thinks the dr. is going over board w/ the tests. I remember that she was diagnosed w/ a kink in her colon many years ago (1980's I think), but that's further down than her stomach, so don't know if they're related.

She said that her chest x-ray hadn't changed since the last one, so the dr. was happy w/ that - when I asked her how far apart the x-rays were she said about a month - since this is a very slow growing infection, I doubt you'd be able to see any change in a month's time - I hope she doesn't get a false sense of security. I think she said that he gave her some antibiotics to have on hand during the flu season in case she does get sick.

Do you feel like banging your head against a wall yet? I will call her tomorrow about the flu shot.

I found this article that says due to improvements in imaging technology, they are now finding more pancreatic cysts. Previously these would have gone undetected. Since they were benign, they were not a cause of concern. There are several different types of pancreatic cysts. It may be possible that Mother's are benign. I'm not sure why they are doing double blood tests and CT scans. Possibly the results didn't agree with each other and they are double checking before making a final diagnosis.
