Dad has seen several doctors the past couple months, including the Chief of Neurology and Chief of Rehab at St. Luke's hospital. The Chief of Rehab has written an order for him to attend outpatient therapy. Mom is following up on that now and he will go as soon as insurance approves it. He is gaining weight, sleeping better and his anti-depressant seems to be helping his outlook on things. He also has an appointment to see a psychiatrist that was recommended by both of the doctors at St. Luke's.

His condition is very complex and changes constantly. This has been the worst 6 months of our lives and we are mourning a living man who was our father and husband. He has improved, but this has been and continues to be a slow and very painful process.

There is no simple solution to this. He claims while at his stay at TIRR, (which is supposed to be one of the best rehab hospitals in the country), that he was abused by the night staff. Of course, they denied any mistreatment that and we had no actual proof. While at TIRR, he got hooked on prescription medications, didn't sleep at night and had hospital acquired infections one right after the other.

He will not be staying with your mother any longer. He is coming home and HIS FAMILY will figure out what next steps we need to take to get him better.

I find it hard to believe that any of you actually care about his welfare. All this family knows how to do is gossip, back-stab and conspire against one another. It is all completely sick and dysfunctional. Someone called Adult Protective Services on my mother and I don't doubt that it was one of your sisters. Anita called CPS on Amy years ago because she felt she was an unfit mother. If it were not for my dad telling Anita that she had made a terrible mistake, Amy might not have her kids. To my knowledge, Amy is not even aware of this.

You have not been down here for any of his recovery.

You have not spent endless hours with him in ICU and the hospital.

You have not witnessed the change in his mental & physical state as well as his personality.

Dear Marta, Happy New Year! I hope you, Ryan and your beautiful daughter are doing well. All of the California clan are looking forward to a great 2011. Being so far away from the situation with Carl has its advantages and disadvantages. I only know what people tell me and what I can gather from the brief, infrequent, phone conversations I have with Carl. I am sick to death by what I have been hearing since Carl was stricken with encephalitis MORE THAN 6 MONTHS AGO. My concern stems from the fact that Carl is not receiving the care and rehabilitation he needs to get his life back. He is floundering, literally and figuratively, and NO ONE seems to have the time, energy, or wherewithal to make the next phase of rehabilitation happen. Carl cannot do it alone, even if he wants to, which apparently he doesn't. Consequently, he needs to be in a facility, RIGHT NOW. The longer he goes without a neuropsychological evaluation and proactive rehabilitation and therapy, the harder it will be for him to recover his brain function. I care very deeply about my only brother and find that I can no longer just stand by and wait for someone to move forward in getting him the help he so desperately needs. Unfortunately, without a court order, my hands are tied. In my very narrow view, it appears that the rest of the family, including your Mother, cares only about money and how others live their lives. I WANT MY BROTHER BACK. I WANT YOU TO HAVE YOUR FATHER BACK. I WANT HALEY TO BE ABLE TO ENJOY HER GRANDPA. I WANT YOUR MOTHER TO HAVE HER HUSBAND BACK. I WANT YOU TO HELP ME MAKE IT HAPPEN. PLEASE. I know you are busy with work, home, and family. I've been there and done that - twice. I'm only asking for your support in my efforts to get Carl on track to recovery. Carl's future and well-being is ALL that matters to me and I will do whatever it takes to get him back! XOXO, Aunt Candy

If he has not gone over, and we still have not had any type of contact from Carl or Drina, I will escalate this to the next level and speak to Tuy's supervisor.

I think we should hire a PI to "find" Carl. If he's at home, he's got to come out sooner or later. If he's in a facility, Drina will have to come out to visit him sooner or later. The problem is, no one knows when these comings and goings will occur and it could cost a lot of money to find out. It's entirely possible that Drina has put him in a facility that is covered by insurance. This makes sense because there have been no requests for money and Carl hasn't called anyone but Mother since he left her house. In any event we have to find out what is going on. If he's in a rehabilitation facility we can celebrate, but she could have stuck him in a nursing home, where none of his needs will be addressed and they will keep him doped up all the time.

The more legwork we do, the cheaper the PI will be. Any ideas on how to find out when his therapy appointments are? If the PI can film him leaving the house and entering the facility we would be able to assess his physical condition and possibly his mental state. If he's in a facility somewhere the PI would have to catch her leaving the house on her way to visit him and if she leaves she could also be going shopping, etc. I would be willing to call rehab facilities if necessary.

I don't want to let too much more time lapse before we find out.

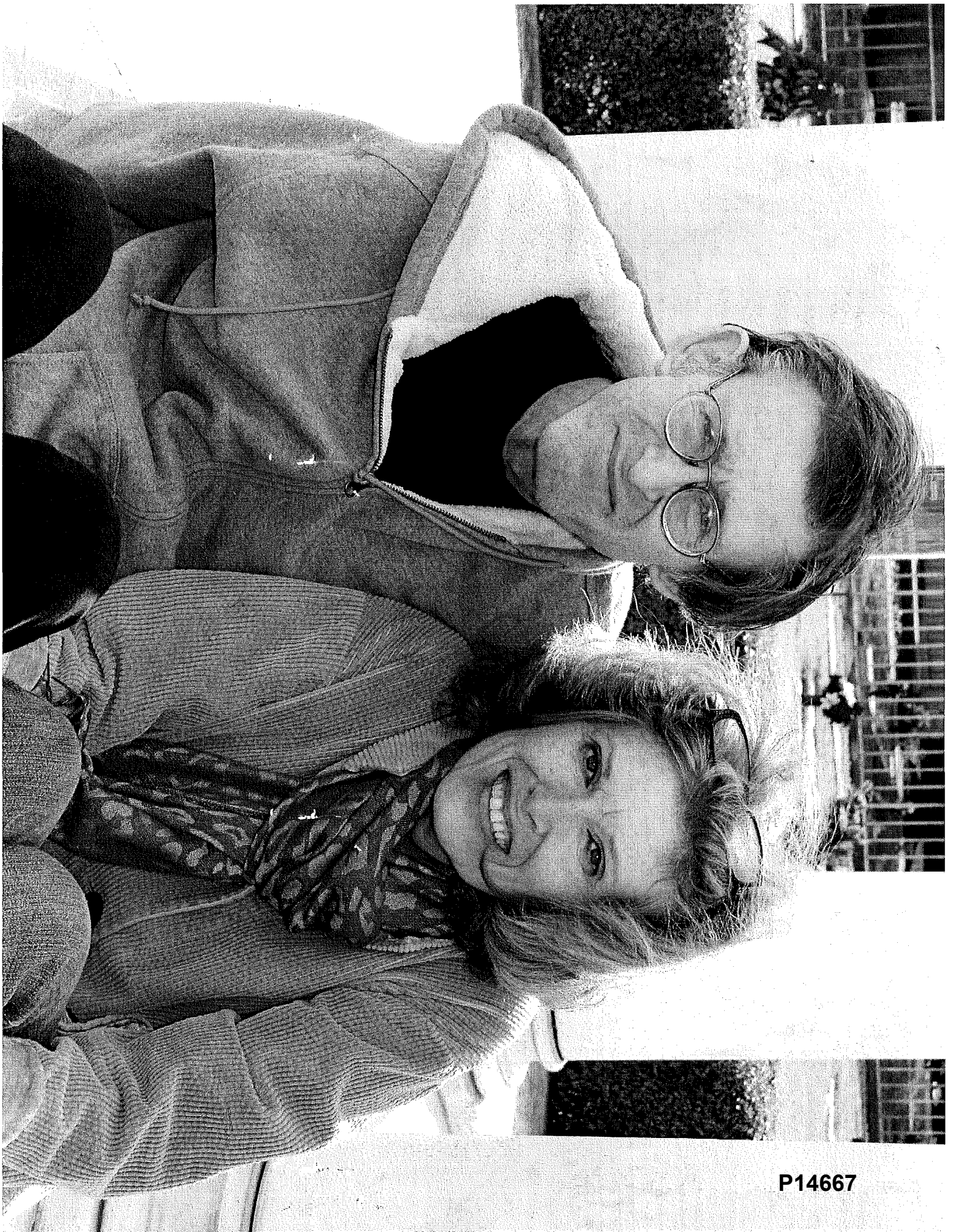

I spoke with Anita about talking to Drina. She is going to work on getting me some numbers so I know what amount is available for Carl. We want to ask Drina to provide us with some documentation of their finances before we decide on what amount she could have on an annual basis. Could you help us make a list of what we need to ask her for?

I was doing some rough calculations. Carl is 53 right now. If he lives to be 85, that is 32 years. If he inherits \$300,000, he could receive \$1386 per month assuming that the account earned an average of 4% per year. That is no where near what Drina is expecting to get.

Hi Candy and Carole,

We are trying to determine the amount of money that Carl can withdraw from the trust. It's hard to determine this since there are so many variables - we don't know how much Mom is going to need for her care, we can't predict the future value of assets, etc. I did some rough number crunching, just so we'd have some place to start. I sent these numbers to Anita and I thought you might have some input about them as well.

If we assume that Carl inherits \$300,000, he lives to be 85 (32 more years), and the account earns an average of 4% interest over the lifetime of the fund, Carl could withdraw \$1386 per month and have enough money to last.

If it were possible for him to inherit \$500,000, he could withdraw \$2310 per month for the rest of his life.

Just to put things in perspective, to receive the \$4000 per month that Drina says they need, he would have to inherit \$865,600, which is not possible. I know if I try to explain this to Drina it will be like talking to a brick wall. It will never be possible to give her the amounts that she wants.

I think we need to send two separate letters. One to Drina telling her she can't come in to Mom's house or contact her by phone or email, and the other to Carl regarding money from the trust. The letters deal with different issues and should be directed to the specific person.

I'm trying to think of some verbage for Carl's letter. This is all I have so far:  
"If you would like to borrow money against your inheritance to pay for your living expenses and medical care, you may borrow up to \$13,000 per year. To receive the funds, submit bills you would like paid from the trust funds to Anita. She will pay them up to the amount of \$13,000 per year. Please sign the enclosed document indicating that you understand the amount you borrow will be deducted from any possible inheritance you may be awarded in the future."

I got the same TM from Tino. I hesitate to promise them anything in writing about money. Rather than a monthly payment, I would rather grant them a certain amount each year, but only through the direct payment of their bills - for example; mom could gift Carl \$13,000/year, but only if they send me the bill statements to pay directly, and only for bills for living/medical expenses - when the trust has paid \$13,000 in bills for the year, that's the end of the money for that year. We could ask them to sign for this money against his inheritance, but then we'd have another form that we'd have to get them to sign (probably notarized), and as we don't know if she's had Carl declared incompetent, the validity of any form he signs might be questionable.

I do like the idea of a letter telling Drina that she may have no contact w/ mom (physical, verbal, visual, phone or electronic means) and she is not to enter mom's house. She can bring Carl to visit mom, but she must remain outside the house - any violation of this letter will be considered harassment and the police will be called if she does not comply. I would also like to add in the letter that Carl's inheritance will be put into a Personal Asset Trust for his care and living expenses - I think this information might be enough to tip her hand.

I would also like to ask Candace, what this letter would do for us legally - like if we did end up calling the police would the letter lend any credence to our case?

I won't do anything until we can come upon an agreement as what to do - I can also write this letter in the role of mom's power of attorney (which she signed last year).

I spoke w/ mom about the whole situation; she listens to reason and can understand our concerns for Carl, and will sign the changes to the trust next week. I have been very forthright in explaining the changes in the trust to her, and that they would be done in order to minimize any pathway that Drina might have to Carl's money. The changes are not to penalize Carl, but to ensure the money goes for his care. I told her to "just say No" to Carl or Drina if they brought up the trust or money and to refer them to me. I reminded her that she isn't trustee anymore and doesn't have access to the trust accounts - she seems fine w/ everything, and expressed no desire to put Carl back on as a trustee. I told her that in the event she did that, that it would not be fair to the rest of us, as we would end up having to deal w/ Drina, not Carl. Mom begrudgingly admits to knowledge of the unpleasantness of this whole situation and Drina's past behavior since Carl has been ill, but I think she is really naive regarding the lengths to which Drina may go through to get Carl's inheritance.

I'm sure you've heard by now about today's incident. I received a TM from Tino who said Carl and Drina went over to Mother's today and that I should call Robert, so I did. As we were talking he kept remembering things that had been said. I told him to write that stuff down because it was all important and all of us need to know what was said.

The time has come to deliver the news to Carl and Drina. Please put your heads together and quickly calculate what CARL would receive monthly for the next 30 years. Since you cannot be sure they receive the information if you email it, and you cannot reason with the moron on the phone, certified mail return receipt requested is the best way to send the information. Put in your correspondence that the first check will be sent on such-and-such date. You can offer to automatically put the \$\$\$ into their account each month.

It's that simple. Once that is done we can all wash our hands of it and just wait and see how it plays out.

I know we would all like to have some visitation and/or phone privileges, but, frankly, the only condition should be that they have to stay away from Mother. I suspect she might actually run off when she realizes that she will have to make some major changes. She probably tells Carl that she WILL

leave if he can't get his money, causing extreme duress and mental stress. The bitch told Mother that Carl worries about the money all of the time, day and night. I still don't think he has regained much cognitive reasoning, so whatever he worries about and says must come from her. We can continue to hope that one day Carl will recover some of his brain power. Maybe he'll wake up one morning and she'll say something hateful about his family and that will be it. Bye, Bye Drina.

I understand Mother has actually gone without her oxygen bottle attached for a couple of hours here and there. Robert said she was a little upset after the visit. This breaks my heart. She said something to Robert about never having children. It is unfair to Mother to even allow Drina in her home. If there's a next time Robert or Tino should make her wait in the car.

After you have written the letter to Carl (I wouldn't even put Drina's name on it), one, two, or all of you should meet at Mother's to show her the letter before Carl and Drina have a chance to start harassing her over the contents of the letter. It's really not an option for Carl to submit bills to be paid and Mother has spent enough of her own money on his care already. Just give him his monthly stipend and let them worry about how they are going to live within their means. It is what it is.

I talked w/ Bret Bosker and he said we needed someone w/ experience in Probate Code, because Probate Court is where guardianship will be argued/decided. I gave him the 2 names of the attys Amy gave and he said they're both excellent (and expensive), but he said he was not sure as to their experience w/ guardianships/probate, but he said we could talk to them about that. He was also going to see if he could find me the name of an atty w/ direct probate experience. So it looks like we have to do 2 steps, 1st get guardianship and 2nd do the divorce if it comes to that. Unfortunately, if you read the website, the spouse is considered 1st in line for guardianship which is why it could be messy to sue for guardianship while they're still married. However, if she plans on divorcing him, then next of kin would be inline and that would be Marta - I think we could talk her out of it as she has expressed no interest in taking care of her father - so after Marta, it would be one of us.

I did tell him that everyone says getting guardianship is expensive, and I asked him "how much is considered expensive" \$50,000 or a million? He said he couldn't answer that, but that the atty we went with should be able to give us an idea.

She was recommended to me by the Burgower firm that Amy's lawyer had given her - the Burgower firm does not do guardianship cases. This atty's name is Ellen Yarrell; her offices are in the Galleria area; she charges an initial consult fee of \$350 for 1 hr of her time, and probably requires an retainer of \$2000. Her paralegal (Elizabeth) said that she's handled cases like this before (where an impaired person has been divorced by their spouse). There is not a mold problem at mom's house. I looked at every air register in

the house. One had a few microscopic dots of mold on it. Robert wiped the register with a bleached rag. I painted over any old stains on the ceilings with 3 coats of oil-based Kilz to seal the surfaces. I inspected the air ducts as far as I could and couldn't find any mold. The ductwork is sheet metal which is not prone to mold growth. In the article you sent, it said that a Level I mold problem was 10 square feet or less. There is not even 10 square inches of mold staining anywhere in the house. The inspector that Carole had check out the system several months ago said the same thing. If the air filters are not being changed monthly, mom may be having a dust problem. We should be using the Filtrete filters or something similar. I will check the filter next time I'm in town.

Hi Anita,

I need some financial help with my medical bills until I can get my diabetes under control. I think I told you I had to take my company insurance when Owen canceled me from his at the end of the year. It's got a \$3,500 deductible. My annual checkup was covered, along with a portion of the blood work. The doctor said I was heading for a heart attack and gave me an EKG. My heart is fine, but the charge was not covered. Some of the blood work was not "routine" and I have to pay for that too. Under Owen's plan I paid about \$10 a month for medications. Now I am taking generic brands but it still costs me \$75.00 a month.

After the fiasco in the ER and stopping the ACE inhibitor I have to go back to the doctor at the end of November and I will have to pay for the visit and the associated labs. I'm going to dispute the ER bill and any related expenses because it was entirely unnecessary. Two doctors failed to notice and point out that ACE inhibitors cause tongue swelling. The first question they asked was what meds are you taking and the nurse entered them into the computer. I was pumped full of steroids and filled a prescription for more before I got back

to the office and discovered the correlation. The steroids caused other reactions for two or three days after I had them. I was finally able to swim this morning and spent some time in the sauna and steam room to try to sweat everything out. I feel 100% today.

If you can help me I can send the bills to you for payment direct, or I can scan them and send them as they come in and you can put money in my account so I can pay them.

It's open enrollment, so I was thinking about changing plans at an increase of \$350.00 per month out of my pocket. I simply do not have it.

Any suggestions would be appreciated.

When I asked him how he was feeling he said fine, "all back to normal". He appears to be somewhat stable at this point, but I don't see how he will ever be able to live without a lot of assistance, with Drina or without.

The Memoirs of  
Nelva Brunsting  
(nee Rensink)



First, a bit about my grandparents I never knew except Grandma Rensink, who I remember as a lady in a black dress. Grampa Rensink died in 1923 before I was born. Grandma died in 1932 when I was six. Grampa and Grandma Koolbeck, I think, lived in Alton till her death. However Mother was born in Pipestone, MN. They had 5 children, Aunt Ethel, Mother, Uncle Jake, Uncle Jim, and Uncle Kenneth. I believe Grandma (nee Nellie TeStroete) died in childbirth when Mother was 9. The children were parceled out to various relatives as was the custom in that day. Mother went to live with Aunt Annie and Uncle Albert Nieuwenhuis in Hospers which is why I considered Aunt Annie as my grandmother because in many ways she was. My Grandfather Koolbeck apparently worked as a drayman in Hospers for awhile and then went to Florida. Aunt Ethel received a letter from him one time that said he had remarried. Other than that no one heard from him again. Uncle Albert was a carpenter and built a lot of the barns around Hospers. They had one son, Nelson, who will be 100 years old in February 2008 and resides in the Pioneer home in Orange City, Iowa. I have 6 cousins on Mother's side.

Dad was the youngest of his family until they adopted Bernie. Dad always said his mother was such a kind person, which is probably why they adopted Bernie. He had 4 brothers and 4 sisters, Uncle Albert (who I never knew because he died in 1908), Uncle Ed, Uncle Arthur, Daddy, and Uncle Bernie. His sisters were Aunt Emma I never knew), Aunt Jennie, Aunt Ann, and Aunt Dena. They lived on a farm near Newkirk and I gather his father was a rather prosperous farmer. He built a big barn that said Gerrit John Rensink on the hayloft door and the year it was built. The farm is still there and the original home. A grandson lived on it until he died this year, 2007. I have approximately 10 cousins on Dad's side. I say approximately because I'm not sure how many of the Wegters are still living.

Mother was in the first graduating class of the Hospers High School. She later went to Iowa Normal College in Cedar Falls to get her teaching certificate and taught for many years in Hospers area schools. Every time we went to Sheldon we would run into someone who had her as a teacher.

Dad just went through the 6<sup>th</sup> grade which was common in those days because the boys were needed to help with the farm work. I think Mother roomed with their family while teaching in a school nearby. This was also the custom then. I think that's how she and Daddy got together.

They were married at Aunt Annie's house on March 12, 1921. At that time women were not allowed to vote. They lost a boy at 6 months (Nelson Earl), then I came along in 1926 and Bud in 1928. I'm not sure which farm he was born on. I only know he was very young when we moved to the farm on the Newkirk road.

I was born on a farm near Sheldon that my Dad was renting at the time. But the earliest home I can recall is on the road several miles north of Newkirk. (None of the original buildings still stand). We had a huge front lawn and Dad would often let Dolly and Rex, our team of horses, graze on the grass. They were so gentle Bud and I would walk

underneath from one side to the other. Now the thought makes me shiver. The house, as I recall, had a big living room (of course when you're small everything seems big), 2 bedrooms downstairs, a kitchen and just one big room upstairs where we would play. Mother had a dresser with materials in it and she told me I once cut pieces out of some to make clothes for my dolls. She didn't say if I got spanked or not. Speaking of dolls, I got one each year until I was 13. I'm not sure when they gave me the doll buggy, which was an exact replica of a real baby buggy), but I would put them all in the buggy and take them for a ride down to the mailbox. Aunt Annie made a sunbonnet quilt for the buggy. Some of their names were Boots, Betty, Lavonne, Ann of Green Gables, Shirley Temple, Baby Jean (a life size doll) and last of all Nancy who came in a little steamer trunk with a wardrobe of clothes plus hangers. Uncle Jim gave her to me. Somewhere along the line I even had a little black doll I called Topsy. Uncle Jim usually gave me a book for Christmas with just a girl's name. Perrine, Nadita, Heidi, Cricket and Pinocchio (only non-girl book) are some of the books I still have. Early on when I was about 7 the folks gave me a blackboard that I could turn into a desk. I still have it and I believe it was my favorite gift.

I started school when I was 4 going on 5. No kindergarten. My teacher was Miss Cleveringa. The first school was about a mile away. My cousins, Ray and Gerrit Diekevers went there too and in good weather Mother, Bud and I would cut through the cornfield to their house and we would go from there picking up some other kids on the way. Ray and Gerrit lived just around the corner from us so we spent a lot of time there.

Bud and I were very close. He was 2 years younger so I was very protective of him. I saved him from drowning in the stock tank one day by grabbing him by his coattails. A farm wasn't always the safest place for kids but we made it. Gerrit and Ray were our closest playmates and Berdella another cousin would come over sometimes also. Mother taught us how to embroidery and I still have a pot holder I worked on. One Halloween Mother dressed up like a ghost when Ray and Gerrit were at our place. Scared us silly. Then she hid our lunches around the farmyard. I had the chicken pox when I was about 5. Don't know if Bud got it or not, but I suppose he did.

We had rabbits at one time and always a dog. One of them, a little terrier, was killed on the road in front of the house and I can still see Bud and me walking back up the drive bawling our hearts out. When I was about 7 I broke a few ribs falling out of a play wagon that Ray was pulling. It was threshing time. I think he turned a sharp corner and I fell out. Dr. Lynn Myers in Sheldon taped me up and I spent several uncomfortable days and nights. The day he took the tape off probably hurt more than the broken ribs.

During the Depression a gang of workmen fixed roads and bridges in the county. One crew camped on our front lawn and at night the folks invited them in and Daddy would play his guitar and some other men had accordions. In the 30's sometimes a hobo would stop by and ask for some food. It was a very difficult time for a lot of people. How they found their way to our farm clear out in the country I don't know.

I remember Mother let me use table boards to set up a corner in the kitchen to play house. On Easter Sunday and usually other Sundays we'd have dinner at Aunt Annie and Uncle Albert. Bud and I had aprons than Mother made and we just left them there. I still have them. At Easter Aunt Annie would hide jelly beans for us to find. If it was nice weather she'd hide some outside. The folks would supply them with butter and cream which they appreciated.

I went to the Newkirk School for the second grade. My teacher was Mrs. Overhaul. So nice. I guess that year the teacher in the other school wasn't very good. Berdella and I were in the same grade. One day Berdella said I was supposed to come home with her after school so I got on her bus with her. It turned out I wasn't supposed to but Mother let me spend the night there. Berdella is the sister I never had.

I went back to Lynn #3 for the 3<sup>rd</sup> grade. Had two very good teachers, Miss Landsman and Nelson Nieuwenhuis who took over for her when she had to quit. During the spring, in March, we moved nearer to Hospers, on what was always called, Uncle Reikel's place. Dad rented from him. He was related by marriage to Mother's aunt. We lived there till I was married.

I think it was that spring Dad had a very bad accident falling off a disc which ran over him. Mother wasn't home at the time but he managed to walk to a neighboring farm where the hired man took him to the hospital in Sheldon. I learned from Mother that we almost lost him. She was sitting by his bedside, called his name. He opened his eyes and said "Why did you call me? It was so peaceful", and he described angels to her. He was unable to work all summer. I can still see him sitting in a comfortable chair at home. The neighbors all pitched in and helped with the field work. That was a very rough year for both of them. As a child I didn't realize how tough. The folks always had company and if there were children we'd play Old Maid or Authors or pick-up sticks. Dad played the guitar very well and also the mouth harp and company would always ask him to play. When I learned to play piano I would accompany him. As a matter of fact, when Mother was in the nursing home in Hull in later years and I was up in Iowa we would go to the nursing and entertain the residents.

We didn't have electricity until I was a sophomore in high school. I can still see Dad lighting a lantern to go to the barn when it was dark. Sometimes I'd get up and make him a cup of cocoa before he went to milk. It was done by hand till in the late thirties when he bought 2 milking machines. The milk was put in a separator in a small room next to the cows. Some of the milk was used for drinking and cooking and also to feed calves (no 2% in those days, only whole milk). The cream went into cream cans and was sold to the Boyden Creamery which sent a tank truck around every week. We kept some cream out for coffee and whipping and making ice-cream (in the summer). We bought butter from the creamery and later they had Land O' Lakes cheese. Dad put the cream cans in the stock tank to keep cool. The house milk was kept in the cellar which was cool. I never really cared for milk until we had a refrigerator.



We always had a big garden and in the summer I had to help pick beans after supper, and other veggies. Hated to do that. Now I would love it. We'd get apples from relatives who had apple trees and Mother would make "appleties"(opelchees) from the little crab apples that were so good. In August and September she would buy boxes of peaches and pears and sometimes apricots and can them. Also the extra tomatoes went into jars or she would made homemade chili sauce. All of these went down in the cellar for the winter.

Mother ironed first with flat irons that were warmed on the cookstove. Later she had a gas iron and of course, later an electric iron.

Our stove was a large cookstove which had a reservoir on the end which was kept full of water to use for bathing, dish washing, etc. The fuel for the stove was corn cobs and sometime wood. Our job as kids was to keep the "cob box" filled. The bin where the cobs were kept was dark and you never knew when mice would be running around. That and getting eggs were not my favorite jobs. It's amazing what good meals were made on the stove and in the oven. Mother later got a gas stove. The other stove was moved to the summer kitchen next to the house. There she did the canning and heat water for laundry use.

As you probably remember, Jell-O was the "All American" dessert in Iowa. In the winter we'd set the Jell-O on the porch which was closed in. It was cold enough to set Jell-O. I don't really know how we got it to set in the summer but we always had Jell-O. Aunt Annie had an icebox.

Heating in the rest of the house was done by a coal stove which was in the living room. In winter Mother would make hot chocolate by setting a pan of milk on top which had an open grate. The fire was "banked" during the night to keep it warm during the night (an open grate was put in the ceiling to let the warm air rise into the bedroom above. But by morning it was pretty chilly in the house. Uncle Albert had a real old fashioned heating stove with ising glass windows in it which fascinated me.

From 4<sup>th</sup> through 8<sup>th</sup> grade Bud and I went to Lynn #4 2 miles away. Dad was director for several years and had to hire the teacher. I think the only teacher we had there was Miss DeSmet from Rock Valley. She was very good and taught us manual training. Several things I made, including the bear bookcase upstairs won a prize at the county fair. She would also take us kids who wanted to go to a movie every now and then and afterward for hamburgers at a little place next to the Woolworth store. They were so good!!! I guess there was a total of about 8 or 10 students at the most in grades from 1 to 8. Miss DeSmet roomed with a family who lived about a ¼ miles from the school. They were Catholic and so was she so it worked out well. During nice weather we'd walk to school along with a neighbor boy whom we detested. He was always bragging about something. The last farm before school had a big red bull in the pasture and we were always afraid of it. Also in those days gypsies still roamed around and by that time they had cars. In winter Dad would take us or if the snow was too bad he and the neighbor put runners on the corn wagon and took the fences down and rode across the section to the school. The fields had less snow than the roads. We kids would sit down in the wagon

covered with blankets. One time the car quit about a half mile from home and we walked the rest of the way holding a blanket in front of us. Came close to having frostbite that time! One year we had a family of 4 children, the Meyers kids, who were quite poor. The oldest, Annie, was a large girl and wore men's shoes to school. The funny thing was that no one made fun of her. We were just kids together. During recess we'd play softball or once in awhile we'd go into the neighboring alfalfa field and drown ground squirrels. Some one would pour water down the hole and when they came up somebody else would "bop 'em in the head".. They were a nuisance to the farmer. We also played different games but mainly softball. In winter we'd play in the basement of the school and some of us had roller skates and took them to school. Also in winter the mothers would take turns bringing a hot dish for our lunch. Usually it was soup or something similar.

At the end of my 8<sup>th</sup> year I had to go to high school in Hospers and I was scared to death to go to such a **big** school. Fortunately, cousin Berdella was in the same grade and her brother Henry and Cousin Ray were already there. There were 17 in our graduating class!

My favorite time in the summer was threshing in July. Oats was grown then and had to be cut with a binder and the shocks had to be stacked in the field like little tents. That's when farmers had hired men if they didn't have help of their own family. When I was old enough(24 or 15) I would run the binder sometimes. Got a good sunburn that way. Someone in the neighborhood would own a threshing machine and go from farm to farm with his machine. All the neighbors would help each other but the best things were the lunches and dinner served the workers. The ladies would pull out all the stops. In the mid morning and afternoon we'd bring the men a big kettle of coffee or lemonade to drink in between time, sandwiches, cookies, cake, etc., but dinner was the best. Mother would always check with Daddy to see what the last lady served the day before. She didn't want to serve the same thing. When it was our turn the aunts would come over and help cook and serve. Since it was during the summer there were always tomatoes, cucumbers, cabbage salad, and everything else. Usually pie for dessert. Sometimes the men would eat in 2 shifts.(Some artist painted a picture of that very thing. It was either Hart or Grant Wood). There were those who brought in the shocks from the field in hay wagons and others tended the machine and the blower and stacked the straw (terrible job), others would bring the oats in the wagon to the elevator on the farm yard where it would be put in the bin . When one place was finished the men would go to the next place. The women always ate after the men were through. We would do the cooking in the summer kitchen so as not to heat up the kitchen where the men ate. When I was a teenager I helped with the blower sometimes. After it was all over we'd have a party at someone's house where the men would settle up the cost they owed the thresher man, I guess. Dad had several different hired men during the years. Those were lean years for a lot of people so many young men went out looking for work. One we had was from Wyoming (Don Kipp). He drank a lot and didn't last long. Another, Neil Rupke was from Kansas. Very nice man. He married and moved to Michigan and worked in one of the car plants, I think. We kept in touch with them for years. Our favorite was from

South Dakota, Lawrence Naminga. He married and went back to South Dakota to farm.. We also kept in touch with him for many years.

In the early 40's I guess, maybe late 30's Dad bought his first tractor, an Oliver. He was very proud of it. Later he bought a John Deere.

There was a creek in the pasture where we played in the summer and "skated" in the winter. When it snowed Dad would pull on our sled behind the car. Lots of fun!!!

Our drinking water came from the windmill in the pasture or soft water from the pump by the house. I didn't care much for the soft water(the cup we used is in the bookcase in the kitchen., it's which enamel). We had another well on the yard but the water was too hard, they said, to drink. But every year Dad and Mother would make homemade root beer and put the bottles in a pail down into that well water which was very cold. Best root beer I ever tasted!!!!.

On my birthday in my teens mother would take me to a drugstore in Sheldon for a banana split. There was a special smell in drugstores in those days that was so pleasant. That's where I also bought my movie magazines. Had my bedroom walls covered with pictures of Clark Gable, Joan Crawford, Van Heflin and all the big stars of the day.

I loved Christmas, although I didn't realize until I was a teenager that we weren't very rich. When I was 9 to 12 I'd take the Sears Christmas catalog or Montgomery Ward and go through them and make a list of the things I wanted to get everyone in the family. Of course, I didn't, but it was fun. My favorite store in Sheldon was Starretts. Every Christmas they turned the basement into a toy and gift store. The tricycles were stacked up high. That's where my Anne Shirley and Shirley Temple dolls came from. I bought Mother a cookie recipe book that had a wooden cover on it. Bud bought her a pin cushion (upstairs on the window sill). Sheldon had a lot of nice stores, dress shops, men's shop and jewelry stores. Penney's, Wolfes, the White House, Ellerbroeks, etc. They're all gone now.

Mother always bought a box of chocolate covered cherries for the family. That was our special treat. I believe they were \$.25 a box then. Later went up to \$.50. We didn't always have a Christmas tree but one year Dad and Mother bought a lovely one and set it up in the living room which faced the road. Mother had **real** little candles (no electricity) which she carefully placed on the tips of the branches and let burn for a little while. One evening she lit them and told Bud and me to go outside and look at the tree through the window. We did and to our amazement each candle had a complete halo around it. It was just like in the pictures we had seen. I still have some of the candle holders and early decorations she used. We usually went to Aunt Annie on Christmas and exchanged presents with Aunt Ethels' family and Nelson and Isabel, Aunt Annies' son who lived in Hospers. Our church always had a program that the little kids took part in and afterwards we would get a bag of candy which also contained an orange and some nuts. The best things were the several chocolate drops they put in. My Dad taught me to chord on the guitar and when I was about 10 they asked me to accompany the smaller kids while they

sang "Silent Night". We practiced on Saturday afternoon. When we were finished the kids asked me to play something else so I played one of the songs Dad taught me "Show me the way to go home. I'm tired and I want to go to bed. I had a little drink about an hour ago and it went right to my head. Wherever I may roam, on land or sea or foam You will always hear me singing that song, show me the way to go home." Afterward I told Mother the kids asked me to play something and I told her what I played. I will never forget the look on her face. She said "NELVA, you shouldn't play that song in church."!!!! I really couldn't figure out why she was so upset. Grampa was a teetotaler so I really didn't know the song was a drinking song. Anyway, they let me play for the kids so I guess word didn't get out.

We always went to The First Reformed church in Hospers even when we lived near Newkirk. Aunt Annie and Uncle Albert also went there. Sometimes we would sit with them and Uncle always had a supply of pink or white peppermints (we called them peppies" in his pocket which he would pass to us during the service. Somewhere I read that it was a Dutch custom in Holland too so that's where it must have come from. I loved to sing with Dad and Mother. Dad had a really nice baritone voice, and Mother would sing soprano and I alto. During those years they also had afternoon services in the Dutch language. Sometimes we would go with our folks. I never could figure out how they could sing those Dutch psalms. Then there was a church member who was very bald and short. His name was Mr. Haack. He would often give a prayer which went on and on but I rather enjoyed listening to the cadence of his voice. When he went real high I figured he was asking God for the forgiveness of our sins. The Dutch services stopped somewhere in the 50's I think because the young ministers couldn't speak the language.

I loved Sunday School. My favorite teacher was Mrs. Dick Kreykes. When we were small Bud and I were in the same class. One year they wanted to separate us and we both cried so they let us stay together. We had a little red song book and got a card with a picture on it and a Sunday School paper. And one year a chart that each Sunday we put a picture of one of the apostles on it. When I was a teen we sometimes had Nelson as a teacher. He was excellent. Maybe because he was also a History teacher.

Bud and I first learned to ride bikes on a neighbor's boy's bike. The road from our house to the mail box about a 1/4 mile away sloped downhill so it wasn't too long before we were riding well. Later Dad and Mother bought us bikes. I never had a girl's bike. When I went to high school I rode bike in nice weather. Since I lived furthest out I'd stop at Virginia Kersten a mile away and later we'd pick up some others. Sometimes we'd walk too. It was about 5 miles. Dad would take me to Kerstens and Virginia and I and a couple of the Boender children walked from there and picked up 1 or 2 other along the way. Sometimes Virginia and I would be the only ones riding our bikes. She was my best friend during high school days.

Thanksgiving was always special too. I especially liked going to Aunt Ethel and Uncle Herm Moret in Orange City. They would always have turkey and had a big living room and dining room. After noon dinner we kids would go to a movie downtown. They

always would have a good kids' movies like Little Women or a Shirley Temple movie. That was the Koolbeck side that got together at Orange City.

For the 4<sup>th</sup> of July Dad's side or at least the Diekevers and Uncle Cornie Rensinks and sometimes even Uncle Jake Koolbeck and Aunt Ethels would come over because Dad would order fireworks from a company in Indiana. In the evening he would shoot off rockets, etc. and we'd have homemade ice-cream. Dad would order rockets, twirlers you tacked to fence posts, sparklers, snakes and cherry bombs and firecrackers which we would put under a tin can to blow it up sky high and Roman candles. We were always very careful because Mother would remind us of a boy she knew who lost a finger or two by being careless. Dad made a trough for the rockets and angled it so they would go up in the air. He'd put it in the middle of the road. Of course, we had very little traffic on the country road. But one time the trough fell off its perch just as he lit the rocket and it went zigzagging down the road. Highlight of the evening!.

We had relatives in Minnesota and Wisconsin. We went to see them several times and they would come to see us at times. They were relatives on Aunt Annie and Mother's side. If we went to Wisconsin we would leave about midnight for some reason. Aunt Annie and Uncle usually went along. I remember seeing a full moon over a lake somewhere along the line. I still have Portage, WI chocolate milk bottle that we bought along the way. No cartons in those days. We stayed at Aunt Annie's half brother one time They lived not too far from Lake Michigan. We got up early one morning and drove down to the shore to see the fishermen bring their catch. We had fresh fried fish for breakfast. Deelish!!!! While there we had a new cereal, Cheerios. After we got back home the Wisconsin relatives sent us a couple of boxes. Bud and I were probably the first ones in Iowa to have Cheerios.

Hog butchering was a big deal. It was always done in the winter to keep the meat from spoiling. Usually our neighbor helped with it. He may have gotten half for all I know. In early days the meat was canned and Mother made what is called headcheese for use as a bread spread. Balkenbrei was made from cracklings, buckwheat flour and a few other ingredients and molded in a pan and sliced off and fried for breakfast and eaten with syrup. So good!! In later years when meat markets had coolers we'd buy a cut of beef from the market and store it in their freezer. When Mother wanted some we'd go to Hospers and get what we wanted out of our locker.

I realize now the education I received in Hospers wasn't a very good one. In fact, Mother probably had a better one in those first years than I did. She had Latin. However, the exception was music. We had an excellent music director, Mr. Thostenson who later became music director at Central College in Pella. He directed the band and mixed chorus and girls' glee club, all of which I participated in. I also sang in a trio and did solo work at contest time..

Both Berdella, her brother Henry and I played clarinets in the band. Our favorite time of the year was going to music contests. One year our band went to the National contest in Minneapolis and won 1<sup>st</sup> for bands for school of our size. I bought Mother a cameo pin at a dime store that I still think was worth more than the \$1.98 I paid for it.

One year the girls took woodworking for 6 wks and the boys took Home Ec. My second cousin, Nelson Nieuwenhuis was shop teacher. I can't for the life of me remember what I made but I do remember working on the lathe.

We had algebra (made an A as a freshman and F as a senior as did my best friend Virginia). Mr. Bomgaars had us repeat it till we passed. Also had American Lit. which I loved, History, English, and Science (which was a joke). Somehow I made salutatorian of my senior class. There wasn't too much competition, I guess.

During my sophomore year Bud and I contracted scarlet fever. We seemed to have been the only ones in the county to get it. I recovered shortly but Bud developed a strep infection and had to be taken to Sioux City and put in isolation for awhile. Mother stayed with him. Doc Galman, our local doctor in Hospers drove her to Sioux City. I looked after Dad. Later we had to have the house fumigated. Bud also had measles when he was younger. I never got them but I did have my appendix removed when I was about 10 or 11. Spent some time in the hospital in Sheldon. We always blamed it on green apples I ate at a friend's house the day before.

Every year the seniors had Skip Day. For ours we went to Sioux Falls and toured the newspaper plant and went to a movie. It was Ingrid Bergman and Humphrey Bogart in Casa Blanca. That was a big day for us! Another big day was going to Sioux City to have our senior pictures taken. That also was a day away from school.

In the winter when the weather was bad or when we had an out-of-town basketball games I stayed with Aunt Annie because for 2 years I was one of the cheerleaders. Virginia Kersten, my best friend, and second cousin Lavonne Raak were the other two. The upstairs bedroom at Aunt Annie wasn't very warm and I would take a warm flat iron to warm the bed. But by morning the room was frigid. As simple as they were I always liked the meals Aunt Annie served. For supper we'd often have fried potatoes, a boiled egg, macaroni salad or something like that. Then afterward we'd play Chinese checkers.

December 7, 1941 was the day the Japanese bombed Pearl Harbor. It was Sunday and we heard the news on the radio. I went to bed that night and cried because I thought sure the Japanese were going to take over America. FDR was president at the time and he was a steadying influence, I think. He was the one who said "We have nothing to fear but fear itself". Food, tire rationing went into effect very quickly. Sugar, butter, coffee were the main foods. Also nylon stockings. That's when leg painting came into being. It wasn't too successful because it would rub off on the clothing. Speed limit was 45 mph. Living on the farm we weren't as badly affected as those in cities and town because we had a garden and Mother sometimes churned butter. Bud and I went through the grove looking for old iron which was collected by the government to make tanks, etc. I do remember making cakes with Karo syrup. I don't remember if oleo came into being then or later. Anyway the first oleo came as a white stick with a yellow capsule that you mixed with it to give it some color. I think Sanka came in about that time. It was supposed to take the place of coffee but tasted horrible. We didn't have a problem with

meat because Dad did his own butchering. We ate a lot of Spam though'. I rather liked it. Some of us high school girls were pressed into service when people had to apply for ration cards, etc. They'd come to the gym to register.

I don't know but it seems to me we had more snow than they do now in northern Iowa. I can remember snow plows coming past during the night to open the roads and the banks would be so high you couldn't see the top of a car passing by. We had high snow banks on the yard too.

After I graduated from high school I decided to go to college. The PR man from Central came and talked to us. I was the only one that signed up for that college. Nelson had gone there too. Actually only 3 or 4 others from my class went to college. I had applied to a nursing school in Sioux City but was too young to get in then. (I graduated when I was 16). Virginia, my best friend, did get in and became a nurse. At that time the Sioux County kids going to Central took a train from Hawarden to Des Moines and from there on a bus to Pella. Gas rationing was still in effect so it was too expensive to drive very far. I met two girls from Sioux Center who were also going to Pella and I stayed overnight at my Aunt Elsie Koolbeck who also lived there and rode with them to Hawarden. She made me a box lunch. That's when I had my first tuna sandwich. We stayed overnight at a hotel, went to a movie, and got on a bus the next day to finish our trip. Elmer was on that train too but he was a big important senior and didn't notice me. He talked to the Hull kids who were going.

The dorm at that time was taken over by the Navy who housed cadets training there in some sort of program, I think it was flying. So they put us up in private homes. I lived at Mr. and Mrs. Herbert Van Wyck's home (he was the Bible professor) along with 3 other girls. Donna Davis, my roommate, Harriet Ten Boer and Dorothy Busby. It was several blocks from the college campus but sometimes I would go over for breakfast, particularly when they had coffee cake. Meals were absolutely delicious. We had from scratch chocolate pie with real whipped cream and pineapple Bavarian cream, etc. No wonder I ballooned to 175 that first year!!

I sang in the glee club and a small madrigal group. We did the Messiah at Christmas time and when I was a sophomore I had the alto part in a quartet that sang the section, "When In Adam All Men Die". Much to my surprise Mother showed up at my room late the afternoon of the performance. She had taken the bus to Pella. I had no idea she was coming!. I think it was the nicest surprise I ever had with her in the audience that evening!

There was no dancing on campus but we did do the Virginia Reel at a get acquainted party. That night Elmer walked me back to the house where I stayed and it kind of went on from there. We went to movies, etc. and by the time we went home for Thanksgiving I was wearing his class ring. He gave me a set of pearls for Christmas and left for the Navy the end of December.

The dorm was returned to the girls by sophomore year. My roommate was Harriet Ten Boer who lived at the house the previous year. She was a senior and very sweet girl.

Elmer and I became engaged in the spring when he was through with basic training in Plattsburgh, New York.

Dad couldn't see sending me back to school since we were going to be married when he got back and Mother had a very bad case of eczema so I stayed home to help her.

Before he went overseas he came home on leave and we discussed getting married. Our fathers got in on the discussion and we decided it wouldn't be the best thing at the time. Elmer was overseas about 14 months.

In April before Elmer came home in May of '46 we had a very bad tornado in the area. We had been making hay that afternoon and the sky in the northwest was very dark all that time. About chores times Mother happened to listen in to the party line and heard someone say there was a tornado coming. Bud tried to back the Model A out of the corn crib and got it hung up so we ran down to the neighbors who had a basement. The tornado came down out of Minnesota and crossed over the highway south of Sioux Center going east. (My Uncle Jake saw it cross the road). It ruined several farms around Newkirk and Hospers. The tornado finally went back up into Minnesota. If it would have taken the usual path it would have hit our farm. The next day was perfectly beautiful but hot. Everyone was out to see the damage that had been done. Fortunately no one was hurt as most people had basements to go to.

Elmer came home in the middle of May and was supposed to have a long leave but he was alerted they were going to decommission the ship so we decided to get married so that I could go to California with him. We had about 2 weeks to get ready. Fortunately I already had my dress. Mother called our relatives and Elmer's mother called theirs. A lady in Orange City who Aunt Ethel knew made our cake. Our minister was out of town so we asked Rev. Harry Van Kerhoff who preached in Elmer's church to do the ceremony. That was just as well with us. Our minister was such a boss at weddings, telling everyone how to walk etc. Aunt Mic who had come to Iowa with Elmer was my maid of honor, Berdella was my bridesmaid. We borrowed dresses for both of them. John Fonkert, a close friend of Elmer's was best man. Evelyn Brunsting played the organ and her sister, Lucille, sang. We had ordered flowers from a Sioux City florist but because of a train strike they couldn't ship them so we hurriedly got some from the Sheldon florist. We drove to Sioux City to get our napkins. Our reception was at my Aunt Ethel in Orange City. It was cold and rainy the day we got married but the next day was bright and sunny.

We drove to California in the '40 Ford that Elmer purchased before coming home. He found a wristwatch inside the door when he took it off to fix one of the windows. The motels in those days were not as modern as they are today. We ran into a sandstorm in New Mexico and our clothes were covered with pink dust. The car wasn't exactly air tight.



After the ship was decommissioned we drove to L.A. and stayed with Uncle Bert Ridders and Aunt Eleanor for a few days. Went to the Capistrano Mission, Knotts Berry Farm, and spent a few days on the beach, stopping at The Grand Canyon on the way back. Stayed in a log cabin that had no heat. It was cold!! Ran into a rain and hail storm south of Sioux City on the way back and spent some time under the roof of a gas station.

Elmer applied to Iowa State College for graduate school and was accepted that fall. We bought a secondhand trailer from someone in Sheldon and lived in West Court at Ames along with all the other GIs who were going back to school. I got a job along with several other girls typing addresses for the Reuben Donnelly Co. who had an office in Nevada about 10 miles from Ames. The company was actually in Chicago. At Thanksgiving we were given a fresh turkey from the butcher shop in Nevada. The most delicious bird I have ever tasted. We cooked it at Elmer's folk's house. The last two years I worked in the Math Dept. on campus. Really enjoyed that. We could go home for lunch.

We bought a typewriter with chemical key symbols on it and I typed Elmer's thesis on it. He graduated in the spring of '50 and took a job with Vulcan Copper and Supply in Cincinnati, Ohio. We first lived in a quadruplex in Pleasant Ridge area and later bought a new little house in North College Hill. In 1953 we added Candy to our family.. The first night we had her home I got up every half hour to see if she was still breathing. One of the fellows whom Elmer really liked was leaving the company and going to Niagara Falls to take on a job with Olin-Mathison. Elmer wasn't too happy at Vulcan so we moved to Niagara Falls too. We rented an apartment on Grand Island between Buffalo and Niagara Falls. The best thing I can say about that period is that we did get to see the Falls. Elmer's job was government work and he couldn't talk about it besides we didn't particularly like the area.

In January we got the call that Bud was lost at sea. Candy and I got on a train at Buffalo and headed for Iowa. She was 10 months old at the time. Entertaining a 10 month old on a long train ride was quite an adventure. We had an upper berth for sleeping. Had to change trains in Chicago in the morning. Candy had her breakfast in the train station. I believe it was oatmeal. Elmer came a few days later and really took charge of things. A sailor accompanied Bud's body. He stayed at Aunt Ethel's overnight. It was a difficult time for all of us.

While we were in Iowa Candy learned to walk by pushing a footstool over the folks dining room floor. It was linoleum. I have a picture of her doing that. Elmer went back to New York before Candy and I so we made the long trip back again.

Shortly after we got back Elmer saw an ad by John Deere looking for chemical engineers at a new urea plant in Pryor, Oklahoma. Since we were none too happy in New York and wanted to get back to the Midwest he answered it and was hired. Elmer preceded us to Pryor and my folks drove Candy and me down there. He had rented a small new house

there so it was all ready. Later we built a larger house in a circle where several other Deere employees lived. I think it was probably the happiest time of our lives. The rest of the family were born there. Carol in the old hospital, Carl, Amy and Anita in the new hospital. And as they say "The rest is history."

I didn't realize they taught cat herding in law school. Since you also advise our Mother in HER best interests, I wanted to give you a little history along with my two cents worth.

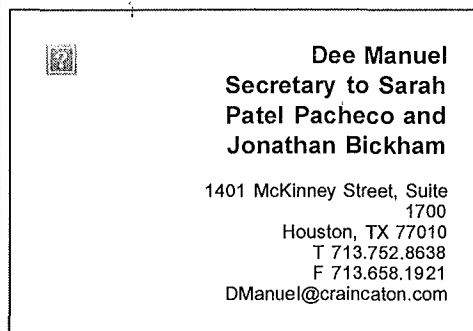
